

Summer Camp 2018

Welcome to Four Seasons Summer Camp Program! We are so glad that you and your child will be spending the summer with us! We have a summer full of fun planned, including exciting activities, arts and crafts, field trips, educational programs, swim time and much, much more!!! A schedule of important dates to keep in mind has been included in this packet, and weekly lesson plans will be posted in your child's class for a complete overview of your child's daily camp schedule.

Attached you will find several important and informative documents that need to be read and signed by both parents and students. All paperwork should be completed and returned as soon as possible to ensure your child's acceptance into our program. Should you have any additional questions, please feel free to address them to Ms. Debbie, Ms. Gina, or Ms. Georgia.

A Few Reminders...

- ❖ The tuition for Summer Camp is \$145 per week. This includes all admissions and bus fees for field trips with the exception of an additional fee charged if your child participates in the Tree Top Adventure. Beyond that, it is unnecessary to send additional spending money with your child on field trips.
- ❖ School-age room assignments will be made and posted on May 25th in an effort to divide the classes into specific age groupings. Class size will depend on the number of children enrolled but will not exceed the state standards.
- ❖ If you should decide that your child is unable to attend a particular field trip **regardless** of the reason, or if your child arrives after the bus leaves for the trip, you will need to make other arrangements for your child on that day, as there will not be teachers available at the center to care for them.
- ❖ Please speak to your child about appropriate behavior on field trips and at the center. Should your child's behavior become an issue, the director reserves the right to revoke future field trip privileges, require the student's parent to accompany them or dismiss the child. If field trip privileges are revoked, the student may **not** come to the center on field trip days, as the student's teacher will not be there.
- ❖ All campers must be **COMPLETELY** potty-trained to participate. Campers who have multiple accidents will unfortunately be dismissed from the program. Due to enrollment capacities in other classrooms, alternate care within the center will not be available.
- ❖ All school age children are required to bring a lunch each day that meets USDA requirements. Cold storage is not available. We recommend that you pack your child's lunch in an insulated lunch bag with an ice pack. On non-field trip days only, microwaves are available to heat your child's food and the center will provide milk for all students at lunchtime. You must pack a drink on field trip days. Four Seasons will provide a healthy morning and afternoon snack for all campers each day.
- ❖ Please remember to take bathing suits and towels home on Fridays.
- ❖ Please make sure all items from home are labeled with your child's name. Four Seasons cannot be responsible for any lost or stolen items.
- ❖ Please arrive 30 minutes BEFORE scheduled field trips.
- ❖ Please remember to dress your child appropriately. We recommend that your child wear socks and sneakers each day as they offer the greatest protection for their little feet. Many field trips REQUIRE SOCKS and campers will not be able to participate without them. Please refrain from sending your child in flip flops/sandals particularly on field trip days, as they pose a potential tripping hazard.
- ❖ Keeping your child safe and busy with exciting adventures is the key to having a great summer. Parents are encouraged and welcomed to join us on field trips, at the pool and/or for special events as their schedules permit. Please feel free to let us know if you would like to take part in any of the fun!

FOOD POLICY (2018)

Four Seasons will provide lunch and snacks for all preschool children. Our menus are USDA approved and very healthy. The menus and times are posted on the wall by the office door.

Four Seasons provides afternoon snack for all school age children during the school year and two snacks for the school-age children during the summer , as well as milk at lunchtime on non-field trip days. All School-age children should bring their lunch everyday during the summer, as meals are NOT available to be purchased at the center. A microwave is available on non-field trip days to heat lunches brought from home for your convenience. **Parents are responsible for making sure that their child's lunch is stored properly each day. WE DO NOT PROVIDE COLD STORAGE**, and therefore recommend that students bring their lunch in thermal lunch totes with ice packs. All lunches must be healthy and meet the following USDA guidelines:

USDA GUIDELINES FOR LUNCH

- 1) **1CUP OF MILK**
- 2) **2OZ MEAT, POULTRY, OR FISH
OR 1EGG
OR 2OZ CHEESE
OR ½ CUP COOKED DRY BEANS OR PEAS
OR 4 TBSP PEANUT BUTTER AND OTHER "BUTTERS"**
- 3) **2 OR MORE OF VEGETABLES AND/OR FRUITS (3/4 CUP EACH)**
- 4) **1 SLICE OF BREAD OR BREAD ALTERNATIVE**

SAMPLE LUNCHES:

1. **PB&J SANDWICH, 1 SLICE OF CHEESE, CARROT STICKS, 1 APPLE, AND 8 OZ OF MILK**
2. **TURKEY SANDWICH, SLICED ORANGES, POTATO SALAD AND 8 OZ. MILK**

IF YOUR CHILD'S LUNCH IS MISSING A COMPONENT, WE WILL PROVIDE THE COMPONENT AND ADD A \$1.00 FEE PER COMPONENT TO YOUR ACCOUNT. If your child has a food allergy, it is the parent's responsibility to provide the USDA meals. If your child is on a NON-USDA diet, we must have a doctor's note for our files and parents must provide their child's NON-USDA meal. There will be no reduction in tuition when parents provide food, as we purchase all foods in bulk, and preschool parents may not provide meals unless warranted. We do not serve breakfast and foods are not permitted from home in the morning. However, we do serve a breakfast snack at 9:00 A.M. and encourage all parents to serve their child breakfast at home before coming to the center.

Summer Camp Pool Rules

4. Only get into the pool using the steps.
5. Only get out of the pool using the steps.
6. No jumping off of the steps.
7. No rough play in the pool.
8. Always be aware of others around you.
9. Keep the pool area clean.

BY SIGNING THIS AGREEMENT I AM GIVING UP MY RIGHTS AND THE RIGHTS OF MY SPOUSE AND/OR CHILD(REN) TO SUE JUMPOLOGY FOR ANY INJURY, INCLUDING PARALYSIS OR DEATH, CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR FAULT OF JUMPOLOGY,

INCLUDING ANY OF ITS AGENTS, EMPLOYEES AND EQUIPMENT. Initials: _____

In consideration of being allowed to participate in the services and activities, including, but not limited to, trampoline park access, trampoline dodge ball, trampoline basketball, aerial training, fitness classes, trampoline courts, foam pit activities and snack bar access and any other amusement activities (collectively "ACTIVITIES"), provided by JUMPOLOGY VIRGINIA, LLC and its agents, owners, officers, directors, principals, volunteers, participants, clients, customers, invitees, employees, independent contractors, insurers, facility operators, land and/or premises owners, and any and all other persons and entities acting in any capacity on its behalf (collectively "JUMPOLOGY"), I, on behalf of myself, and/or on behalf of my spouse, minor child(ren)/ward(s), hereby agree to forever release, indemnify and discharge JUMPOLOGY on behalf of myself, my spouse, legal partner, my children, my parents, my guardians, heirs, assigns, personal representatives and estate, and all other persons and entities as set forth below. The undersigned, for myself, and/or on behalf of my spouse, minor child(ren)/ward(s), hereby acknowledges, agrees and represents that immediately upon entering or participating I will, inspect and carefully consider JUMPOLOGY'S premises and facilities. It is further warranted that such entry into JUMPOLOGY'S facilities for observation or use of any facilities or equipment or participation in ACTIVITIES constitutes an acknowledgement that such premises and all facilities and equipment thereon have been inspected and carefully considered and that the undersigned finds and accepts same for myself, and/or on behalf of my spouse, minor child(ren)/ward(s) as being safe and reasonably suited for the purpose of such observation, use or participation by myself, and/or by my spouse, minor child(ren)/ward(s). The undersigned, for myself, and/or on behalf of my spouse, minor child(ren)/ward(s) hereby represent that (i) I/we are in good health and in proper physical condition to participate in the activities in which JUMPOLOGY provides; and (ii) I/we are not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my/our ability to safely participate in activities; (iii) I/we have not been advised against activities by a health professional. I agree that it is my sole responsibility to determine whether I/we are sufficiently fit and healthy enough to participate in activities. The undersigned, for myself, and/or on behalf of my spouse, minor child(ren)/ward(s), agree to be familiar with and to abide by the rules established for the ACTIVITIES, which include without limitation the rules posted in the facility and/or the website. The undersigned, for myself, and/or on behalf of my spouse, minor child(ren)/ward(s), accepts sole responsibility for my own conduct and actions, as well as the conduct and actions of my spouse, minor child(ren)/ward(s) while participating in the activities, and the condition and adequacy of the equipment.

(1) **RELEASE OF LIABILITY:** Despite all known and unknown risks including but not limited to serious bodily injury, permanent disability, paralysis and loss of life, I, on behalf of myself, and/or on behalf of my spouse, minor child(ren)/ward(s) hereby expressly and voluntarily remise, release, acquit, satisfy and forever discharge and agree not to sue JUMPOLOGY, including its suppliers, designers, installers, manufacturers of any trampoline equipment, foam pit material, or such other material and equipment in JUMPOLOGY'S facility (all hereinafter referred to as "EQUIPMENT SUPPLIERS") and agree to hold said parties harmless of and from any and all manner of actions or omission(s), causes of action, suits, sums of money, controversies, damages, judgments, executions, claims and demands whatsoever, in law or in equity, including, but not limited to, any and all claims which allege negligent acts and/or omissions committed by JUMPOLOGY or any EQUIPMENT SUPPLIERS, whether the action arises out of any damage, loss, personal injury, or death to me or my spouse, minor child(ren)/ward(s), while participating in or as a result of participating in any of the ACTIVITIES in or about the premises. This Release of Liability, is effective and valid regardless of whether the damage, loss or death is a result of any act or omission on the part of JUMPOLOGY and/or any EQUIPMENT SUPPLIERS.

(2) **INDEMNIFICATION:** I understand that the known and unknown risks may be caused in whole or in part by my or my spouse or child(ren)/wards own actions or inactions, the actions or inactions of others participating in activities, or the acts, inaction or negligence of JUMPOLOGY or any EQUIPMENT SUPPLIERS, and in consideration of being allowed, along with my spouse and/or my minor child(ren)/ward(s) to participate in the ACTIVITIES, I hereby assume all risk of damage, loss, personal injury, or death to myself, my spouse and/or my minor child(ren)/ward(s) as a result of the participation in ACTIVITIES in or about the facility, including any such loss due to any negligence of JUMPOLOGY and all EQUIPMENT SUPPLIERS and agree to indemnify and hold harmless JUMPOLOGY and all EQUIPMENT SUPPLIERS from and against any and all losses, liabilities, claims, obligations, costs, damages and/or expenses whatsoever paid, incurred and/or suffered by JUMPOLOGY and all EQUIPMENT SUPPLIERS as a result of any claims asserted by myself, my spouse and/or child(ren)/ward(s) against JUMPOLOGY and all EQUIPMENT SUPPLIERS, including, but not limited to, any and all attorneys' fees, costs, damages and/or judgments JUMPOLOGY and all EQUIPMENT SUPPLIERS incurs in the event of such loss whether caused by the negligence of JUMPOLOGY or any EQUIPMENT SUPPLIERS and that on behalf of myself, my spouse or my minor child(ren)/ward(s) I further agree to indemnify and hold harmless JUMPOLOGY for any injury, damage and/or harm myself, my spouse and/or my minor child(ren)/ward(s) cause to JUMPOLOGY or its facility and/or to any and all other persons and entities acting in any capacity on behalf of JUMPOLOGY.

(3) **ATTORNEYS' FEES:** I promise to indemnify JUMPOLOGY for any attorneys' fees and/or costs incurred to enforce this



agreement, including all costs associated with any collection efforts. Further, should any debt and/or judgment accrue in favor of JUMPOLOGY, pre-judgment and post-judgment interest shall accrue thereon at a rate of 18% per annum.

(4) **PHOTO RELEASE:** By entering JUMPOLOGY and participating in the ACTIVITIES, I hereby grant JUMPOLOGY on behalf of myself, my spouse and on behalf of my child(ren)/ward(s), the irrevocable right and permission to photograph and/or record me, my spouse or my child(ren)/ward(s) in connection with JUMPOLOGY and to use the photograph and/or recording for all purposes, including advertising and promotional purposes, in any manner and all media now or hereafter known, in perpetuity throughout the world, without restriction as to alteration. I waive any right to inspect or approve the use of the photograph and/or recording, and acknowledge and agree that the rights granted to this release are without compensation of any kind.

(5) **TERMS OF AGREEMENT:** I understand that this agreement extends forever into the future and will have full force and legal effect each and every time I or my spouse and/ or child(ren)/ward(s) visit JUMPOLOGY, whether at the current location or any other location or facility. The undersigned further expressly agrees that this agreement is intended to be as broad and inclusive as is permitted by the laws of this state and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

(6) **VENUE:** In the event a lawsuit is filed against JUMPOLOGY, I agree to the sole and exclusive venue of Henrico County, Virginia. I further agree that the substantive law of Virginia shall apply without regard to any conflict of law rules.

By signing this document, I understand that I may be found by a court of law to have forever waived my and my spouse and/or child(ren)/ward(s) right to maintain any action against JUMPOLOGY on the basis of any claim from which I have released JUMPOLOGY and any released party herein and that I have assumed all risk of damage, loss, personal injury, or death to myself, my spouse and/or my minor child(ren)/ward(s) and agreed to indemnify and hold harmless JUMPOLOGY and all EQUIPMENT SUPPLIERS from and against any and all losses, liabilities, claims, obligations, costs, damages and/or expenses whatsoever paid, incurred and/or suffered by JUMPOLOGY and all EQUIPMENT SUPPLIERS as a result of the participation in ACTIVITIES in or about the facility by myself, my spouse and/or child(ren)/ward(s) and/or claims asserted by myself, my spouse and/or child(ren)/ward(s) against JUMPOLOGY and all EQUIPMENT SUPPLIERS related to such participation in ACTIVITIES. I have had a reasonable and sufficient opportunity to read and understand this entire document and consult with legal counsel, or have voluntarily waived my right to do so. RULES FOR KD'Z KIDZ WORLD BOUNCE HOUSE FACILITY

Safety First – Read and follow all safety rules as you – the signee – are responsible for safe operation while participating and hold harmless KD’z Kidz World, LLC.

SPECIFIC RULES TO FOLLOW:

1. **SOCKS ARE REQUIRED:** For ADULTS and CHILDREN on the carpet and bounce houses at all times.
2. **Children must be 48” or taller to participate in/on The Wiped Out, no exceptions.**
3. **NO SHARP OBJECTS:** Remove all sharp object prior to entering the bounce houses.
4. **NO EYE GLASSES:** Do not wear eye glasses while in/on the bounce house. All person(s) must remove glasses, jewelry, and anything else that may cause harm to themselves, to others and/or the bounce houses.
5. **NO FLIPS/SOMERSAULTS OR HORSEPLAY:** Parents must strictly enforce the rules.
6. **NO FOOD, DRINKS, or GUM:** On the carpet or in the bounce houses. No outside food allowed in Facility. Strollers must remain on the tile area
7. **Max weight per person is 225 pounds. – For the safety of everyone, we ask adults only to walk, sit or slide on the inflatables. PLEASE NO HIGH OR HARD BOUNCING.**
8. Charges will be imposed to repair or replace items due to abuse, misuse, overload, or negligence.
9. Children must be supervised at all times by the signee, Parent or Guardian.
10. No walk-in parties, no cakes, no balloons, or toys allowed in facility.
11. All Children from ages 1-17 will be charged to enter the facility. Two parents per family.
12. Once you leave the facility your play time is over.

In consideration of being allowed to enter into the play area and/or participate in the activities at KD’z Kidz World, LLC., the undersigned on his or her owned behalf, agrees to the following conditions:
